


Types of work Contractor Performs

*CONTRACTOR IS TO ENSURE A VALID PERMIT HAS BEEN ISSUED PRIOR TO STARTING ANY PROJECT. MUST START WITHIN 30 DAYS OF PERMIT ISSUE DATE AND PERMIT EXPIRES 1 YEAR FROM ISSUE DATE. CONTRACTOR MUST CALL FOR ALL REQUIRED INSPECTIONS AND UPON COMPLETION OF THE PROJECT.*
